### Diocesan Website

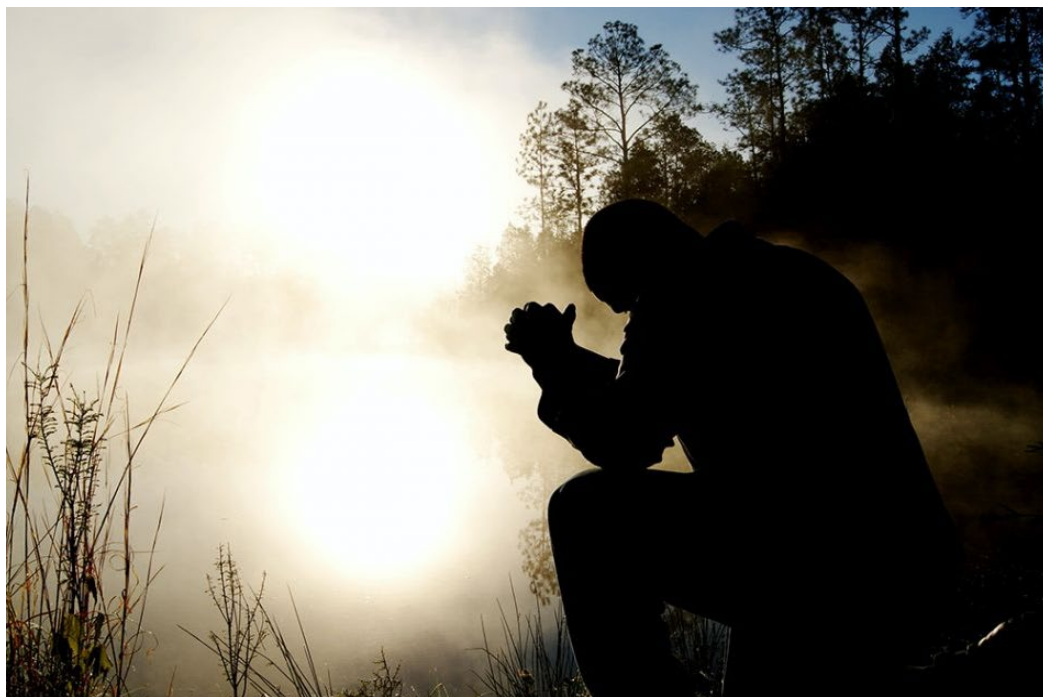
The Archdiocese are developing a brand-new website. The safeguarding section of the website will be interactive with easy access for visitors to our policies, support, resources and more.

We've had a request to provide examples of parish groups which need to have an Enhanced level DBS check to do their role. Some of the most common groups are:

**Children's Liturgists**  
**First Holy Communion and Confirmation Catechists**  
**Children's Play Group**  
**Children's Choir/Music Group Leader**  
**Sacristans**  
**Adult Altar Servers/Coordinators**  
**Mass Coordinators**

**Pastoral Assistants**  
**Eucharistic Ministers**  
**Parish Visitors of the Sick/Elderly**  
**Parish Transport to Mass volunteers**  
**Parish Outreach to vulnerable adults**  
**Bereavement Counsellors**  
**St Vincent de Paul Members**

This is not an exhaustive list and there may be other ministries in your parish which are eligible for an Enhanced level DBS check, so if you need advice please email us the details.

You might also find it helpful to know some parish ministries which do not require a DBS check, including: Readers, Welcomers, Flower Arrangers, Collection Counters, After Mass Tea & Coffee Servers.

### Stop Hate UK: LGBTQ+ Hate Crime

Stop Hate UK have shared an easy guide called 'Understand LGBTQ+ Hate Crime', which is being shared through Local Authorities and Police.

This resource defines the different types of LGBTQ+ hate crimes and covers key points: understanding hate crime law, online hate, how to report a hate crime, taking care of yourself after a hate crime, going to the police and going to court.
